
The challenge to avoid contacting the virus to always be safe, is a real challenge

### MSMEs in the Time of Pandemic




A typical local bakery has an average of five (5) employees – three (3) bakers and two (2) salespersons. There are at least five (5) families relying on the survival of the business. It is in these times that business owners sacrifice their operating funds to support their people and their families. The relief goods these owners receive, instead of giving to their own families, are being distributed to the families of their employees. It is during these times we see selfless acts by people not leaving any of their employees behind.

On March 23, the Department of Labor and Employment (DOLE) launched its COVID-19 Adjustment Measures Program (CAMP) to provide financial assistance of Php 5,000 to each of the employees affected by the temporary closure of MSMEs. Lucky are those with Human Resource Officers who were able to submit their requirements to DOLE for processing of their CAMP. However, a large percentage of qualified micro businesses have not been granted such financial support. Others have submitted, but until

#### How do we embrace the new normal?

Given that that we will deal with the virus every day until a vaccine is made available, how is the health safety guaranteed? # House bill(s) seek to provide a "whole-of-society"

Cited in March 2020, Anti-Spitting Act of 2020, which seeks to ban and penalize spitting, coughing and sneezing in public. Also, a New Normal Law is being pushed that will establish social distancing and health and hygiene protocols. For the working professionals. a proposed House Bill 6623 or the "New Normal for the Workplace and Public Spaces Act of 2020" aims to set standards and protocols to be adopted in the coming years. The local communities are already exercising this new normal habit though House Bills are not yet turned into laws.

now they still are waiting for approval of their applications. Some were not able to submit anymore due to the lack of time accomplishing the requirements and they do not have access to internet. Other business owners opted to just provide the financial support out of their own pockets. Those pending for approval are advised to apply for the Small Business Wage Subsidy (SBWS) by the Department of Finance (DOF), Social Security System (SSS) and Bureau of Internal Revenue (BIR). However, micro businesses who are not aware on how to use SSS portals would likewise not have an opportunity to file for their employees.

Several micro businesses are now trying to resume their business operations to provide essential services to the community. Thanks to the trust and hard work of the business owners and their employees. This challenge has proven that together, "We will Rise as One."

While they have applied for CAMP, the status has remained "pending approval" for some weeks now. But they remain hopeful – they can never give up for the sake of their employees and their families.


Pointers to remember when work is resume:


Employees will be asked to respect distancing rule. Work from home (for those who can do their jobs from home), tele-conferencing or video-conferencing will continue for the foreseeable future.


The country will impose or recommend wearing a mask and a face shield in public places and office spaces. Wearing gloves should be normal from now on.


Many will opt to walk, use scooters, bicycles or even cars instead of public transport for work or short travels.


Below are the infographics about the essential guidelines for the public on how to adjust to "new normal" practices as we go through our daily routine.



# Addressing the Effects of the COVID-19 Pandemic on MSMEs: Insights for

## **Policy Making**



The (MSME) sector is one of the hardest hit by the COVID-19 pandemic and the ensuing ECQ implementation. In less than three months, we saw closure of businesses, loss of jobs, and cash-strapped MSMES struggling to survive. If ECQ was hard for MSMEs, post-ECQ will be harder. It will not be "business as usual". It is critical that the government and other stakeholders provide the necessary and timely support to the MSME sector to pave the way for its survival and eventual recovery.

In this Policy Brief submitted to the Department of Trade and Industry (DTI), the University of the Philippines Institute for Small-Scale Industries (UP ISSI) recommends the following:

- 1. Provide financial grants to cash-strapped MSMEs;
- 2. Facilitate MSME's access to interest-free loans and other financial assistance;
- 3. Look into the feasibility of waiving taxes and other business-related fees of MSMEs for at least six months;
- 4. Eliminate barriers to the movement of goods and personnel in essential sectors;
- 5. Realign budget and allocate to industries severely affected by the pandemic;
- 6. Strengthen the ICT infrastructure in the country;
- 7. Increase the capacity of MSMEs on business continuity planning; and
- 8. Increase the capacity of MSMEs to leverage on disruptive technologies;

"This paper is divided into three sections. The first section provides a brief over `view of the macro- economic impact of the COVID-19 and then zooms in on the findings of the Survey conducted by the Institute on the effects of the COVID-19 on MSMEs, focusing on the current condition of their businesses, challenges they are facing and coping mechanisms. The second section outlines some initiatives and assistance for the MSME sector provided by the government and the private sector. The third section discusses the conclusion and provides recommendations specific to the MSME sector."

Participants of this course came from various industry sectors - service, trading, manufacturing, health, retail, transportation, government industry, and software industry.




Most of the participants are from NCR and Luzon region:
